

## **SCHEDULE OF FEES & UNINSURED SERVICES**

1CLINIC is committed to providing you with the best medical care promptly in a friendly and professional environment. However, there are services that you may request from your physician that are not considered medically necessary by Ontario Health Insurance Plan (OHIP) and are therefore **NOT paid by OHIP**.

These services, such as, insurance forms, legal letters, sick notes, etc., are called "uninsured services". 1CLINIC will charge for uninsured services in accordance with the fees guidelines set by the Ontario Medical Association (OMA) and the College of Physicians and Surgeons of Ontario (CPSO). These services are billable directly to the patient and payment is due on receipt of the service.

Missed appointment (24 BUSINESS hours' notice required)	\$50 + HST
Annual Preventative Functional Assessment	\$250 + HST
Periodic Health Visit, Missed Appointment	\$70 + HST
Office Visit without a valid health card (health card must be present at EVERY visit)	\$120 + HST
Prescription refills without an appointment (Emergency short term refills at physicians discretion only) *	\$30 + HST
Mole Removal (per lesion)	\$500 + HST
Cosmetic Skin-Tag / Wart Removal (Blocks of 3) (Each Additional \$100 + HST)	\$250 + HST
Ear syringing, (not meeting OHIP guidelines)	\$40 + HST
One step TB Test Form Included (not meeting OHIP guidelines)	\$60 + HST
Two step TB Test Form Included (not meeting OHIP guidelines)	\$95 + HST
Corticosteroid Injection	\$200 + HST
Copies / Transfer of Medical Records	\$30 + HST
Travel Medical Advice	Individual: \$120 + HST
Travel letter	Individual: \$80 + HST
Back to work note / Sick Notes / Doctor Notes	\$30 + HST
Notes for insurance coverage of Acupuncture, Compression Stockings Orthotics/Physiotherapy/Massage Notes/Prescription Insurance Coverage, etc.	\$35 + HST
Attending Physician's Statements / Long Term Disability Form (may include examination)	\$150 + HST
Insurance treatment Plan (OCF-18) / Insurance disability Form (OCF-3)	\$160 + HST
Short Term Disability Forms	\$70 + HST
CRA - Federal Disability Tax Credit	\$80 + HST
Immunization forms	\$45 + HST
Non-WSIB FAF Forms	\$65 + HST
